As we celebrate the second anniversary of financial close this month, the entire DWMC project community was delighted to welcome the Crown Prince of Dubai, His Royal Highness Sheikh



His excellency Dawoud Al Hajri the Director General of Dubai Municipality and I welcomed his Highness in the main control room and a presentation was made explaining how the plant will help deliver Dubai's vision for sustainability. Commissioning works are progressing well as we reach the mid point of the year and we remain on schedule for the start of the first Early Operations period in Q3. The project community bid a fond farewell to our EPC Site Manager Mehmet Oguz this month. Mehmet has overseen the timely erection and testing of all the boiler and pressure systems in blocks 1 and 2, and I join with the whole project team in thanking him for his contributions.

Both boilers 11 and 12 have been operating on waste fuel this month, as our commissioning teams conduct the multitude of tests needed to ensure optimal performance ahead of EOP 1. We are expecting the first synchronisation of the steam turbine imminently, and our engineers have been coordinating closely with our DM colleagues in the DS217 substation to ensure a seemless transition to power generation and export. While block 1 moves swiftly towards operations, commissioning works in block 2 have intensified during June. We are expecting first waste deliveries into waste bunker 2 at the end of July, ready for the first firing of boiler 23 which is due early in August. To ensure we have sufficient waste available for the impending ramp up of boiler operations, we have started 24 hour waste reception this month. The last remaining Yong Mao heavy lift crane was dismantled and removed from site this month, signifying the completion of all heavy lifting activities. The remaining high level construction work in block 2 involves panel fitting works, which are carried out using smaller cranes and MEWPS.

HSE Update

To help commemorate World Environment Day on the 5th June, a group from the ENOC HSE team visited the site to learn about how the DWMC project will Dubai's targets for contribute to improved environmental performance and greater sustainibility. The group, lead by Abdulla Al Hamadi the Senior Environment manager with ENOC, received a project briefing, and the group discussed current and emerging sustainibility inititiatives in Dubai. With the start of the restricted summer working hours on the 15th June, our EPC contractor has instigated the Heat Stress Managent Campaign. All project workers and managers are provided with drinking water flasks and additional water stations are erected around the site. Working hours are changed so that no work is conducted outside between 12.30 and 3pm, and site audits are carried out to ensure that all staff are complying with the regime.
